- THE INTERSECTION OF THE RIGHT TO HEALTH & THE RIGHT TO FOOD IS CENTRAL TO ACHIEVING SUBSTANTIVE EQUALITY & TO REALIZING SUSTAINABLE DEVELOPMENT, HUMAN RIGHTS, LASTING PEACE & SECURITY
- THE COVID-19 PANDEMIC INCREASED THE WORLD'S UNDERSTANDING OF HOW MALNUTRITION CAN INCREASE THE SEVERITY OF AN INFECTIOUS DISEASE & HOW PANDEMICS IN TURN CAN WORSEN THE CHALLENGES OF MALNUTRITION. MARGINALIZED GROUPS FACED HEIGHTENED CHALLENGES TO ACCESS FOOD AID DURING THE PANDEMIC
- MULTINATIONAL FOOD & BEVERAGE CORPORATIONS HAVE STEADILY INCREASED THEIR SALES & PRESENCE IN LOWER-INCOME COUNTRIES

  CORPORATE MARKETING STRATEGIES FOR UNHEALTHY FOODS & BEVERAGES SPECIFICALLY TARGET LOWER-INCOME COUNTRIES, WHILE OFTEN PUSHING HEALTHIER

  PRODUCTS IN RICHER COUNTRIES
  - LAND GRABBING, WHEREBY INVESTORS AQUIRE LAND FOR LARGE SCALE PROJECTS, TRIGGERS POVERTY, FOOD INSECURITY & THE LOSS OF LIVELIHOODS FOR LOCAL COMMUNITIES, WITH HARMFUL IMPACTS ON HEALTH
    - DISPOSSESSING, OCCUPYING & ALLOWING THE DESTRUCTION OF LANDS USED FOR FARMING, HERDING, HUNTING, FISHING & FORAGING ELIMINATES THE ABILITY OF INDIGENOUS & OTHER LOCAL COMMUNITIES TO PRODUCE THEIR OWN FOODS FOR A HEALTHY DIET, TURNING FOOD INTO A COMMODITY CONTROLLED BY THOSE IN POWER

OVER 80% OF THE WORLD'S HUNGRIEST PEOPLE LIVE IN CLIMATE DISASTER-PRONE COUNTRIES, & NEARLY A QUARTER OF THE WORLD'S FARMABLE LANDS ARE DEGRADED -- CLIMATE CHANGE IS PROJECTED TO INCREASE THE RISK OF FOODBORNE & WATERBORNE DISEASES & INCREASE FOOD INSECURITY

A DECOLONIAL APPROACH IS IMPORTANT BECAUSE IT REFUSES TO FRAMING
ALL TOGETHER THAT IN THE ERA OF CLIMATE CHANGE, ENVIRONMENTAL DESTRUCTION
IS OFTEN ATTRIBUTED TO THE REPRODUCTION OF THOSE LIVING IN POVERTY, INDIGENOUS
PEOPLE & PEOPLE OF AFRICAN DESCENT.

EMPHASIZED THE IMPORTANCE TO ESTABLISH MANDATORY FRONT-OF PACKAGE NUTRITION LABELING, GOOD FISCAL & FOOD POLICY WHICH ALIGNS WITH STATES' OBLIGATION TO PROTECT THE RIGHT TO HEALTH & HEALTH-RELATED RIGHTS

TO MOVE FORWARD TO SUBSTANTIVE EQUALITY, IT REQUIRES STARTING WITH THOSE WHO WE HAVE ALREADY LEFT BEHIND WE MUST ENSURE THAT ALL THE EFFORTS & STRATEGIES WE COME UP WITH ARE IN SERVICE OF THE RESTORATION OF THE DIGNITY OF ALL PEOPLE

IN PARAGRAPH 21, YOU MAKE A REFERENCE TO "FOOD APARTHEID" CAN YOU EXPLAIN MORE ABOUT THIS CONCEPT?

## DRT:

UNDER "FOOD APARTHEID", WE SHOULD SPEAK ABOUT STRUCTURAL DISCRIMINATION & HOW SYSTEMIC IT IS, WHICH TARGETS THOSE IN POSITION OF LESS POWER. WHEN YOU DO AN ANALYSIS OF POWER, YOU THEN REALIZE THAT THESE PEOPLE ARE TARGETED BECAUSE THEY DO NOT HAVE SOCIAL CAPITAL OR POWER FOR PREVENTION, FOR RECOURSE OR TO SEEK ACCOUNTABILITY. THESE UNEQUAL & UNJUST CONDITIONS FURTHER DRIVE THE SAME COMMUNITIES FURTHER TOTHE MARGINS. THIS DISCRIMINATION, IN TERMS OF LAWS, IN TERMS OF POLICIES DELIBERATELY LEADS TO NEGATIVE HEALTH OUTCOMES.
