H.B. 3496: Community Re-Entry through Addiction Treatment to Enhance (CREATE) Opportunities Act (same as **S. 1983**) authorizes the Attorney General to make grants to, and enters into cooperative agreements with, States and units of local government to develop, implement, or expand one or more programs to provide medication-assisted treatment to individuals who have opioid use disorder and are incarcerated within the jurisdictions of the States or units of local government. **H. B. Status:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security. **S. B. Status:** Read twice and referred to the Committee on the Judiciary.

Harm Reduction/Treatment

H.R. 2569: Comprehensive Addiction Resources Emergency (CARE) Act of 2019 (same as **S. 1365**) provides emergency assistance to States, territories, Tribal nations, and local areas affected by the opioid epidemic and makes financial assistance available to States, territories, Tribal nations, local areas, and public or private nonprofit entities to provide for the development, organization, coordination, and operation of more effective and cost efficient systems for the delivery of essential services to individuals with substance use disorder and their families. **H.B. Status:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security. **S.B. Status:** Read twice and referred to the Committee on Health, Education, Labor, and Pensions.

H.R. 4460: Turn the Tide Act (same as **S. 2102**) provides funding for programs and activities under the SUPPORT for Patients and Communities Act. **H.B. Status:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security. **S.B. Status:** Read twice and referred to the Committee on Health, Education, Labor, and Pensions.

H.R. 4974: Medication Access and Training Expansion Act of 2019 amends the Controlled Substances Act to require physicians and other prescribers of controlled substances to complete training on treating and managing patients with opioid and other substance use disorders (which shall also satisfy certain training required to receive a waiver for dispensing narcotic drugs for maintenance or detoxification treatment), and for other purposes. **Status:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 2922: Respond NOW Act establishes an Opioid Epidemic Response Fund and expands access to treatment. **Status:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.

H.R. 1302: Expanding Opportunities for Recovery Act of 2019 requires the Center for Substance Abuse Treatment in the Substance Abuse and Mental Health Services Administration to award grants to states to expand access to clinically appropriate services for opioid abuse or addiction. States must use these grants to provide up to 60 consecutive days of services to individuals who otherwise would not have access to substance abuse services. **Status:** Referred to the Subcommittee on Health.

H.R. 4111: Combating Meth and Cocaine Act (same as **S. 1925**) authorizes State opioid response grants and provides grants for preventing or treating the abuse of psychostimulants, such as cocaine or methamphetamine. **H.B. Status:** Referred to the House Committee on Energy and Commerce. **S.B. Status:** Read twice and referred to the Committee on Health, Education, Labor, and Pensions

H.R. 2482: Mainstreaming Addiction Treatment Act of 2019 (same as **S. 2074**) amends section 303(g) of the Controlled Substances Act (21 U.S.C. 823(g)) to eliminate the separate registration requirement for dispensing narcotic drugs in schedule III, IV, or V, such as buprenorphine, for maintenance or detoxification treatment, and for other purposes. **H.B. Status:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security. **S.B. Status:** Read twice and referred to the Committee on Health, Education, Labor, and Pensions.

Insurance and Tax

S. 1424: MORE Savings Act promotes affordable access to evidence-based opioid treatments under the Medicare program and requires coverage of medication assisted treatment for opioid use disorders, opioid overdose reversal medications, and recovery support services by health plans without cost-sharing requirements. **Status:** Read twice and referred to the Committee on Finance.

S. 425: Budgeting for Opioid Addiction Treatment Act amends the Internal Revenue Code of 1986 to establish a stewardship fee on the production and importation of opioid pain relievers, and for other purposes. **Status:** Read twice and referred to the Committee on Finance.
